### (b) Bills and Communications:

#### (c) New Business:

The Acting Assistant Secretary, Brother **Ramey Packer**, read the 2025 Semi-Annual Temple Board Report on Income and Expenditures, and on Assets and Liabilities, pursuant to CMC §900.050. The report also included updates on facility maintenance issues, complete management turnover, and ongoing financial constraints.

The Senior Warden, Brother **William Workman**, noted discrepancies in the 2025 Semi-Annual Temple Board Report. Washington Lodge No. 20 pays disproportionate rent, the highest rent paid by any Owning Body. This issue has been brought up before but not resolved by the Temple Board. Brother Workman also noted that the fire alarm system should be under warranty.

The Master, Worshipful **Joseph Wallach**, reported that **Nancy Hardiman**, spouse of Worshipful **Phil Hardiman**, **PM**, passed away on August 15, 2025, and announced that her Celebration of Life will be held on Saturday, September 06, 2025, at 11:00 AM, in the Ballroom of the Sacramento Masonic Temple.

The Junior Deacon, Brother **Nicholas Johnston**, noted a typo in the agenda for the total amount of bills, that it should have been \$ 17,607.28, as reported by the Treasurer, Worshipful **Eric Hixson**, **PM**, instead of \$16,607.28, as printed on the agenda.

The Senior Warden, Brother **William Workman**, moved to donate \$200.00 to NorCal DeMolay. Seconded by Brother **Christopher Hamilton**. The Junior Warden, Brother **Brandon Jekins**, inquired if the Lodge had enough money left in the budget for such a donation. The Treasurer, Worshipful **Eric Hixson**, **PM**, reported that we are currently over budget for Charity.
