### **(b) Bills and Communications:**

The Treasurer, Worshipful **Eric Hixson, PM**, gave the monthly report of bills for **November 2025** in the amount of \$ **6,319.64**. Audited by the Senior and Junior Wardens. Worshipful **Eric Hixson, PM**, moved that the bills be paid. Seconded by Worshipful **Francisco Marques, PM**, and approved by the Lodge.

The Secretary, Worshipful **Francisco Marques, PM**, read the following:

- Annual Communication: Legislation Results

Regarding "Grand Master Salazar's Decision No. 1 (Esoteric or Secret Portion of the Ritual)," Worshipful **Matthew Mason, PM**, clarified that signs, words or modes of recognition in our Ritual are the "esoteric or secret portion" of the Ritual; but that doesn't mean that all other elements of the Ritual should be written down explicitly.

A question was raised by Brother **Nicholas Johnston** regarding the purpose of placing the Decision No. 1 on the agenda for a vote at the Annual Communication, noting that its provisions mirror current Masonic practice regarding ciphered portions of the Ritual.

**(c) New Business:**

• **Remission of Dues (CMC §809.360)**

The Secretary, Worshipful **Francisco Marques, PM**, moved that the Lodge approve remission of the 2025 Annual Dues for one (1) member, in accordance with CMC 809.360, as recommended by the Charity Committee. Seconded by Brother **Ramey Packer** and approved by the Lodge.

• **Request for Demit (CMC §804.130)**

The Master, Worshipful **Joseph Wallach**, informed the Lodge that Brother **Marco Eloy Lopez (160969)** had requested cancellation of his membership with our Lodge, acknowledged his Request for Demit, and asked the Lodge Secretary, Worshipful **Francisco Marques, PM**, to immediately issue each respective Certificate of Demit on the form provided by Grand Lodge, as evidence of the withdrawal. The Secretary presented the Certificate of Demit to the Master for his signature.

• **Temple Board (CMC §900.010)**

Worshipful **Jared Yoshiki, PM**, thanked the members for the opportunity of serving as the Lodge's representative on the Temple Board. He reported that recent discussions at board meetings have focused on finding ways to cover expenses.

A contract with the owners of **Locked Barrel (KJ, LLC)** will provide a new revenue stream, but it is not expected to be sufficient for emergency expenses. The contract will not affect Washington Lodge's use of the Ballroom on Stated Meeting nights.

Worshipful Yoshiki noted that while our Lodge is fiscally sound, this is not true for all shareholders. He raised the question of our Lodge's future financial commitment to the building, especially in the event of a catastrophic issue.

He also mentioned that the **Masonic Temple Association of Sacramento (MTAS)** is a corporation and that California laws will influence decisions when not all owning bodies can contribute capital. He questioned the potential liability for the Lodge. He plans to propose updates to the MTAS Bylaws, specifically regarding the term "judging," as its absence could make directors personally liable.

After answering questions from Worshipful **Mauro Lara, PM**, and Worshipful **David Cameron, PM**, Worshipful Yoshiki expressed his willingness to schedule regular meetings with Lodge members to provide updates and answer questions.

## **Oration**

The Musician, Brother **James Dimmitt**, reminded us that, in Freemasonry, the Letter G prominently symbolizes both God (as the Great Architect of the Universe) and Geometry, the "divine science" upon which the fraternity's moral and philosophical teachings are founded. He demonstrated (assisted by Brother **Ramey Packer**) that the Golden Ratio appears in the proportions of the human arm and hand, creating an aesthetically pleasing and harmonious structure. The proportion of your forearm (from elbow to wrist) to your hand (from wrist to the tip of your middle finger) is in the Golden Ratio. The ratio of the length from the wrist to the elbow to the length from the elbow to the shoulder is also approximately in the golden ratio. From a Masonic perspective, the Golden Ratio can be viewed as an example of a "divine order" or "design" in the universe. The beauty and harmony observed in nature and in the human body can be interpreted as evidence of God's existence and creative power.

The Senior Steward, Brother **Maury Hicks**, reported cash donation received during dinner in the amount of **\$160.00** to the Refreshment Fund and gave the monies to the Secretary.

The Chaplain, Brother **Ramey Packer**, extended his congratulations to Worshipful **Eric Hixson, PM**, on the occasion of his retirement and expressed gratitude for his significant contributions and dedication to the Washington Lodge over many years as Treasurer.

A battery of three times three was led by the Master-Elect, Brother **William Workman**, as a tribute to Worshipful **Eric Hixson, PM**. Worshipful Hixson offered remarks of gratitude and shared mixed emotions regarding his upcoming retirement.
