*"Dear Outreach:*

*My Father, William Newton Statzell was a member of Washington Lodge #20 and was a member of the Ben Ali Band for over 50 years before his death. My Mother is now 97 and I am asking if the Masonic Order offers outreach services to assist her with living arrangements. She has been in a private home for about two years but has finally run out of savings and the room and board exceeds her income. My husband and I are willing to have her live with us but we both work fulltime at Sacramento State University and are fearful of my mother being alone during the day. She is blind from macular degeneration, a diabetic and suffers from bone density loss which caused her to break her hip two years ago. She is still lucid and enjoys books on tape from the society for the blind and also enjoys the company of others. Any advice you can give me would be greatly appreciated.*

With the guidance and support of our Ambassador of Fraternal Support Services, Brother Dave Freeman, a year later, on March 14, 2011 we received again from Ms. Carolann Statzell Forseth the following letter which with her permission we are sharing with you.

*"Dear (Past) Master Joseph Dongo:*

*I beg your understanding that this letter of appreciation is so tardy. Below you will see the letter I sent you a year ago on March 8, 2010. Thanks to your quick response in forwarding my inquiry and request, MOS has made it possible for my Mother to remain where she was residing and maintain her quality of life. As I said in my letter, she outlived her savings and we were unsure of what the future held for her.*

*My father was so proud of his long affiliation with the Masonic Order, the Scottish Rite and the Ben Ali Shrine Band. Perhaps as a child I didn't see the relevance but now as an adult, it's plain to see all the good work that is done for the brotherhood of mankind. The caseworkers assigned to my Mother take a genuine interest in her wellbeing and for that I will be forever grateful.*

*I have a good friend, Dr. William Dillon, also a member of Washington Lodge #20, who suggested that I ask this letter to be included in your monthly newsletter to show just how your important work affects the community of its members in such a positive way. My Mother will be 99 years of age in July and thanks to the care she receives from the Masonic Outreach Services, she is thriving!*

### MASONIC LAWN

For those unaware, there is a Masonic Cemetery in Sacramento and it's located at 2700 Riverside Boulevard. It consists of 7.5 acres and was purchased in 1875 for \$5,000 by five Masonic lodges: Tehama #3, Washington #20, Union #58, Sacramento #40 and Concord #117. The Cemetery is open to the public.

A trust was initially established to assess a per capita tax of \$ .03 per month per member to pay for maintenance and debt service. Cemetery costs are now covered by a perpetual care fund, investment returns and sales of burial plots. A Masonic Lawn Association was established in 1918 with two representatives appointed or elected from each of the five Lodges. Currently Washington Lodge #20 representatives are David Freeman and Richard Pullen. The ten Board of Directors along with a full time manager, who also serves as the Association secretary/treasurer, provide oversight for the maintenance and care of the grounds. There are also two full time groundskeepers on staff. The 2011 budget of approximately \$230,000 covers payroll and cemetery operations.

A computerized system is now available to provide for identification and location of some 5,000 burial sites. This can be done on a computer by going to [www.masoniclawnassociation.com](http://www.masoniclawnassociation.com).

There are currently 75 regular burial plots remaining at a cost of \$3,000 to \$4,000 each, and 100 cremating spaces at \$500 each.

The skills of the cemetery staff have provided for very attractive and well maintained grounds which are a pleasure to view. Cemetery hours are 8am to 4:30pm daily and the office is open


