The Assistant Secretary, Worshipful **Joseph Wallach, PM**, read a letter from Brother **Nicholas J. Butcher**, Senior Warden of Martinez Lodge No. 41, requesting monetary donations in support of the **Bags for Kids** program, which provides school supplies to second-grade students in need in the city of Martinez, California.

### (c) New Business:

The Assistant Secretary, Worshipful **Joseph Wallach, PM**, read the 2025 Annual Hall Association Report, pursuant to CMC §900.050.

The Board Director, Worshipful **Jared Yoshiki, PM**, announced that the Annual Temple Board Meeting is scheduled for Monday, March 23<sup>rd</sup>, 2026, at 7:00 PM. He also informed the lodge that KJ, LLC has agreed to address several repairs and complete painting work in the Ballroom.

When asked by Brother **Kevin Hall** about the status of property tax payments and if a capital call would be needed, Worshipful **Jared Yoshiki, PM**, stated that no additional monies are required from Washington Lodge No. 20 at this time.

Upon inquiry from Worshipful **Matthew Mason, PM**, regarding why not all details of the contract between KJ, LLC and MTAS were disclosed in the Annual Report, Worshipful **Jared Yoshiki, PM**, stated that he would request detailed documentation from the Temple Board, including copies of the relevant meeting minutes.

Worshipful **Matthew Mason, PM**, inquired about the transition from deficit in 2024 to profit in 2025. Worshipful **Jared Yoshiki, PM**, and Brother **Brandon Jenkins** responded, also addressing matters related to the fire alarm failure in 2024 and employee retention.

The Treasurer, Worshipful **Mauro Lara, PM**, moved that the Lodge reinvest **\$140,000.00** of our matured corporation bonds into like bonds that will yield roughly 4% or better, as recommended by the Budget & Investment Committee. Seconded by Worshipful **Joseph Wallach, PM**, and approved by the Lodge.

The Assistant Secretary, Worshipful **Joseph Wallach, PM**, read the Sacred Roll *in memoriam* of Brother **Joaquin Jesus Lopez** (02/09/1992 - 02/23/2026).

### **Oration**

The Junior Steward, Brother **Carlos Brusel-Casals**, presented a philosophical reflection on **Grammar**, the first of the Seven Liberal Arts and Sciences.

### **Examination**

The Senior Warden, Brother **Brandon Jenkins**, conducted the Examination upon Brothers **Ivan Flowers** and **Isai Jaimes**, who demonstrated an excellent level of proficiency in the assigned portion of the lecture of the Entered Apprentice Degree.

After congratulating the Candidates, the Master directed all Entered Apprentices to retire and declared the Lodge to be at refreshment and labor resumed on the Second Degree of Masonry for the purpose of Examination at **9:01 PM**.

The Senior Warden, Brother **Brandon Jenkins**, conducted the Examination upon Brothers **Anthony Ibarra** and **Kelvin Kimball**, who demonstrated an excellent level of proficiency in the assigned portion of the lecture of the FellowCraft Degree.

After congratulating the Candidates, the Master declared the Lodge to be called from refreshment to labor on the First Degree of Masonry at **9:15 PM** and directed the Junior Deacon to invite Entered Apprentices back in the lodge room.
