(c) New Business:

The Secretary, Worshipful **Francisco Marques, PM**, moved that the Lodge approve the remission of dues for three (3) members, in accordance with CMC 809.360, as recommended by the Charity Committee. Seconded by Brother **Mauro Lara** and approved by the lodge. The Master, **Russell Tomas**, informed the lodge that four (4) members had requested remission of dues, but one case requires further investigation.

The Secretary, Worshipful **Francisco Marques, PM**, moved that the Lodge approve the suspension of membership for nine (9) members for non-payment of dues, in accordance with CMC 809.370, as reported by the Member retention Committee. The Master, **Russell Tomas**, informed the lodge those members were sent notices via certified mail, return receipt requested, postage prepaid, addressed to their last known address, as required by the CMC. Seconded by Brother **Nicholas Johnston** and approved by the lodge.

The Senior Steward, Brother **William Workman**, reported the cash received as donations for stated dinner in the amount of \$120.00 and gave the monies to the Lodge Secretary. He also reported the amount of \$30.72 received online via Square (app) as previously disclosed by the Lodge Secretary before the Stated Meeting.

The Inspector of the 414th Masonic District, Worshipful **Michael Woo, PM**, addressed the Lodge and conveyed fraternal greetings from Most Worshipful **Jeffrey Wilkins**, Grand Master. The Inspector also expressed his appreciation for the outstanding level of fellowship experienced in our Lodge, and for our efforts to bring in new candidates as well as promote the progress of the existent membership. “The pandemic has paused but not stopped us,” he imparted in closing.
